## KWAYE

uSection 16(i) weRental Housing Act 50 ka 1999 ithi "wonke umntu ochasa imimiselo uzobanetyala apho angabanjwa iminyaka emibini okanye abhataliswe imali okanye azifumane zombini."

## UMASTANDI AKAKWAZI "UZENZELA" .

3. Cacisela umastandi ayikho semthethweni into yokucinyelwa umbane (umxelele ngomthetho obhalwe phezulu).

## UBA UMASPALA AKAFUNI UBUYISELA UMBANE, UNGAYA KWEZINDAWO UFUNA UNCEDO:

Amapolisa: kuba ayikho semthethweni into yocinyelwa umbane, amapolisa kufuneka akuncede ubuyisela umbane.

iRental Housing Tribunal: Ungayofaka isikhalazo sika mastandi wakho kuba engafuni ukunika iinkonzo zikamaspala.
